We herewith declare that products placed on the market by Techtronic Industries GmbH comply (partly based on suppliers' information) with threshold level requirements according to the list attached (page 2), and, does not contain any substances of very high concern (SVHC) above 0.1 mass-% per product that are included in the candidate list (Article 59 REACH, updated: January 17<sup>th</sup> 2023), with the exception of Lead (CAS-Nr. 7439-92-1), which may be contained in machined steel, cooper or aluminium parts or specific electronic components of the products, and 1,2-dimethoxyethane; ethylene glycol dimethyl ether (EGDME) (CAS-Nr.110-71-4), which may be contained in lithium button cells integrated in the products.

We comply with taking back requirements for products at the end of their useful life and finance the cost of treatment and recovery of redundant WEEE in accordance with the specific WEEE recycling requirements. The product is marked with the WEEE symbol. We have implemented measures aimed at limiting the production of packaging waste and promoting recycling, re-use and other forms of waste recovery as provided by the packaging and packaging waste directive.
